## **Guidelines and Requirements**

# Producers Need to Submit an Application detailing their scripted TV Drama Project to imontero@camacol.org

## **Required Application Package Materials**:

- Main Producer Contact Info;
- 200 Words or less on how producers would benefit from the experience;
- Production details including Project / Working Title, Synopsis, Key Bios, Casting; Ideas, Financing Plan, reel links, mood boards);
- Projects may be scripted series, feature films, comedies, docuseries, reality shows;
- Dramatic limited /Mini-Series, and Telenovela Projects May be Considered;
- Series Do Not have to be English language to be considered;
- Miami elements (production, post, co-production).

### **Originality and Permissions; INDEMNITY**

Projects must be the original work of the applicant(s)/producers. If based upon another person's
life or upon a book or other underlying work, applicant(s) must secure any necessary rights to
make such adaptations. However, it is not necessary to submit the adaptation or rights
agreements to MMFM Neither MMFM nor its jurists investigates or attests to the authenticity

- of an applicant's statement of authorship or rights secured. By entering the competition, you are acknowledging that you have secured all necessary rights.
- BY SUBMITTING THE MATERIAL, THE APPLICANT HEREBY AGREES TO INDEMNIFY, HOLD
  HARMLESS, AND DEFEND THE FESTIVAL, ITS EMPLOYEES, DIRECTORS, REPRESENTATIVES, AND
  AFFILIATES FROM ANY LIABILITY, CLAIMS, AND DAMAGES IN CONNECTION WITH THE
  SUBMISSION AND FROM ANY FEES AND EXPENSES, INCLUDING BUT NOT LIMITED TO
  REASONABLE ATTORNEYS' FEES, THAT ANY OF THEM MAY INCUR IN CONNECTION THEREWITH.
